

RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

STEP 1**APPLICABILITY**

Applicable in the entire territory served.

AVAILABILITY

Available for general, domestic, commercial and industrial service.

(I) RATES (customers with metered water supply)

First	3,000 gallons used per month	\$ 14.00 per 1,000 gallons
Next	2,000 gallons used per month	\$ 13.20 per 1,000 gallons
Next	2,000 gallons used per month	\$ 12.38 per 1,000 gallons
Next	3,000 gallons used per month	\$ 11.58 per 1,000 gallons
All over	10,000 gallons used per month	\$ 9.62 per 1,000 gallons

(I) MINIMUM CHARGE

No bill will be rendered for less than the following based on meter size:

5/8 inch meter	\$ 42.00 per month
3/4 inch meter	\$ 63.00 per month
1 inch meter	\$ 105.00 per month
1½ inch meter	\$ 210.00 per month
2 inch meter	\$ 336.00 per month
3 inch meter	\$ 672.00 per month
4 inch meter	\$1,050.00 per month
6 inch meter	\$2,100.00 per month

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

(I) RECONNECTION - \$25.00

To be charged whenever the supply of water is turned off for violation of rules, non-payment of bills, or fraudulent use of water.

STEP 1 (Continued)

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the District up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by their bank due to insufficient funds.

(I, C) LEAK ADJUSTMENT INCREMENT

\$4.92 per 1,000 gallons is to be used when a bill reflects unusual water consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above 200% of the customer's historical usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

EFT, CREDIT CARD AND DROP BOX PAYMENTS FOR PUBLIC SERVICE DISTRICTS

A service charge will be imposed on EFT, Credit Card or Drop Box payments. The amount shall be equal to the actual charges to the utility from the financial institution for processing payment. No additional charge or fee shall be collected by the District for accepting these forms of payment.



Available for general, domestic, commercial and industrial service.

(D) RATES (customers with metered water supply)

First	3,000 gallons used per month	\$ 13.29 per 1,000 gallons
Next	2,000 gallons used per month	\$ 12.52 per 1,000 gallons
Next	2,000 gallons used per month	\$ 11.75 per 1,000 gallons
Next	3,000 gallons used per month	\$ 10.99 per 1,000 gallons
All over	10,000 gallons used per month	\$ 9.13 per 1,000 gallons

(D) MINIMUM CHARGE

No bill will be rendered for less than the following based on meter size:

5/8 inch meter	\$ 39.87 per month
3/4 inch meter	\$ 59.81 per month
1 inch meter	\$ 99.68 per month
1½ inch meter	\$ 199.35 per month
2 inch meter	\$ 318.96 per month
3 inch meter	\$ 637.92 per month
4 inch meter	\$ 996.75 per month
6 inch meter	\$1,993.50 per month

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION - \$25.00

To be charged whenever the supply of water is turned off for violation of rules, non-payment of bills, or fraudulent use of water.

TAP FEE

RETURNED CHECK CHARGE

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

EFT, CREDIT CARD AND DROP BOX PAYMENTS FOR PUBLIC SERVICE DISTRICTS

A service charge will be imposed on EFT, Credit Card or Drop Box payments. The amount shall be equal to the actual charges to the utility from the financial institution for processing payment. No additional charge or fee shall be collected by the District for accepting these forms of payment.
